Once again rumors have started to spread in our organization, and it is now time to put it all to rest. The rumor is that Voiture Nationale wants to put TAPS back into the membership numbers. I can tell you that the rumor is <u>UNTRUE!</u>

Voiture Nationale would like to see

membership not lose 2000 members each year. So let's look at the problem this year we will wreck more members than we will lose to TAPS, so we must ask ourselves where those members went. Most of them did not renew because they saw no value in their membership, why you ask, well there are a number of reasons, and I do not want to get into them here. But TAPS is not where we are losing our membership, yet we are taking TAPS off your numbers and will continue to do so.

Now the problem is we are patting ourselves on the back for 100%, I want to explain to you why this is not the best way to do things. Last year a Locale had 100 members they lost 5 to death so this year they have to make 95 to be 100%. So the 100% number is 95% that is why we need to look at 105% as the number to reach to pat ourselves on the back, not 100%.

We have more locales at 100% this year and that is great, but to stop the loss of 2000 members a year we will need 105%.

Two years ago when TAPS first came out on the membership number Voiture Nationale started sending out patches and shirts for 100%. The cost of the patches and shirts had to come from somewhere, Voiture Nationale could not afford to pay for them, the membership team went to work and asked some of the programs to put in money to help with membership, some did. Voiture Nationale would like to keep sending out "OVER THE TOP" certificates at 100%, for patches, shirts, and coats the requirement should be 105%, and the TAPS will still come off membership. This will save the membership team from going out and raising money.

## GRANDE CHEMINOT, JUNE 30, 2007 PAGE-1 DOUBLETREE HOTEL, ST. LOUIS COUNTY, MISSOURI

Trying to get his year over, Grand Chef de Gare, Donald W. Fligge, opened the Grande Cheminot at 12:59 P.M. with a salute to the Colors, The Pledge of Allegiance, and the needed prayer by the Acting Grand Aumonier, who else but Arthur L. Wilson, and he stated that the head table needed it the most.

Grand Chef Fligge acknowledge the presence of the Alternate N.E.C. from Missouri, Richard Heigert.

Roll call of officers by the Grand Correspondant showed some excused, some absent, the rest were yo-yo's, weird, obnoxious, or down right mean and it cost them a dollar for the cause. Some even paid more. Roll call of Grand Chefs de Gare Passe showed that we had eleven present, some also paid to the cause. Roll call of Grand Cheminot showed that we had a quorum. Absent were Voitures 293, 333, 447, 520, 848, 966, 1292, 1395, & 1402.

Grand Avocat, William Weiss, stated that we will follow the Rules of Procedure as in the past.

Notion offered by Art Wilson, second by Virgil Morice, that the minutes of the Grand Spring Cheminot be approved as printed and sent out.....passed

The Grand Correspondant read the following resolutions, one for Jerry J. Castulik to be elected to the Executive Committee of the Central States Promenade for another three years and this was sent in by Voiture 1321. The other resolution was from Voiture 448 for Grande Constitution Amendment on Article IV, Sections 1.(A) and (B). And also drop the Disaster Relief Program from the Constitution.

Grand Commissaire Intendant, Robert Phillips, stated that he had distributed the final finance report on the chairs. No acton will be taken until the Audit Committee gives their report tomorrow morning.

Grand Chef de Train, Grant Willis, called on his two Sous Grand Chefs de Train that were the only ones present, David Christian and Robert Emery. Willis reported that we have 13 Voitures at 100% or more. The Grande Voiture is over the top by 2 members. Willis gave out the following awards to Jack Fink of V-448, Ralph Turner of V-460, Gary Reno of V-1379, Marvin Suthers of V-3, and Arnold Miller of V-38. Grant thanked all the Voyageurs for getting the Grande over the top and membership does not end until July 31st. Get those members that have not paid yet. Grand Chef Donald gave out 100% pins to the following: Dennis Russell of V-130, Ralph Turner of V-460, and Sam Guenther of 1403. The other Voitures to receive this pin did not have anyone present.

Grand Cheminot reports were given by Voitures 3, 38, 130, 292, 448, 460, 760, 1321, 1379, 1403, 1541.

Grand Avocat, William Weiss, reported how V-38 received their seed money to purchase their chateau by being a 501-C organization.

Grand Directeur Child Welfare, John Neger, was not present and the Grand Correspondant gave his report. He received only 9 reports with \$186,261.00 being spent. The awards went to 1st place V-1321, 2nd place V-460, and 3rd place V-38.

Grand Directeur Voiture Activities, Ralph Turner, reported that he received only 5 reports. Awards were given to V-1541 for 3rd place, V-1321 for 2nd place, and V-333 for 1st place.

Grand Directeur Nurses Training, Gary Reno, stated he received 10 reports with 3 being no report. Gary reported that we were \$67,000.00 short of last year. The awards went to: 3rd place V-1403, 2nd place V-130, and 1st place V-460.

Grand Chef Don acknowledge the fact that the Alternate N.E.C. from Missouri, Richard Heigert, was present.

Roll call of officers by the Grand Correspondant showed some excused, some absent, a lot less yo-yo's, and the rest were still weird, obnoxious, or down right mean and it cost many of them a dollar. Others paid more. Roll call of Grand Chefs de Gare Passe showed 12 present. Roll call of Voitures showed that we had a quorum. Absent were voitures 293, 333, 447, 460, 520, 848, 966, 1292, 1395.

Also present was Grand Commissaire Intendant, Robert Phillips, and observer Gary Reno. Ray stated they did this on June 30, 2007 on the second floor banquet room of the Doubletree Hotel in St. Louis County at 9:30 AM. The new Grande Chef de Gare, Grant Willis, closed the Grande Promenade in the proper manner at 11:03 AM.

#### **Brief History of Grande Voiture of Missouri**

The first Voiture Locale in the State of Missouri, and the third in La Societe, was organized through the efforts of Harry H. Pierce, Kansas City, Pierce having been initiated at the Promenade in Cleveland, September 29, 1920. Charter was granted November 4, 1920.

Rulif M. Martin was the Premier Chef de Gare of Voiture Trois; Harry H. Pierce, Chef de Train; Robert T. Swofford, Commissaire Intendant and William G. Guthrie, Correspondant.

Voiture 38, St. Louis, followed, application for Charter having been made by Colonel John H. Parker, January 27, 1921. The premier officers elected were: Dr. H. S. Renfrow, Chef de Gare; Francis N. Curlee, Chef de Train, George M. Hagee, Commissaire Intendant and Carleton E. Branch, Correspondant.

Fred Windsor and Clay C. MacDonald were instrumental in perfecting organization of the third Voiture Locale, Buchanan County No. 130, September 21, 1921, to be located at St. Joseph, host city of The American Legion Convention that year. Clay C. MacDonald was named Chef de Gare; A. L. Loving, Chef de Train; Col. H. H. McCord, Commissaire Intendant and F. R. Kirtley, Correspondant.

It was at St. Joseph; the Grande Voiture of Missouri was organized by delegates from the three existing Voitures. At a dinner meeting, to which all Voyageurs were invited, Col. John H. "Gattlin Gun" Parker, St. Louis (38) was elected Grand Chef de Gare and Rulif M. Martin, Kansas City (3) Grand Correspondent.

The Missouri Voyageurs were also hosts to the Promenade Nationale held in Kansas City in 1921.

Mississippi County Voiture 156 at Charleston was organized late in 1921, while others to follow in 1922 were: Boone County 292 at Columbia; Jasper County 293 at Joplin; Linn County 301 at Marceline; Henry County 333 at Clinton; Macon County 447 at Callao and St. Louis County 448 at Maplewood.
