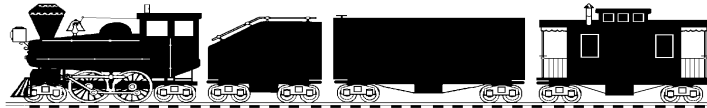

SPECIAL AWARDS

On the 6th of November 2012, 25 Law Officers received the Medal of Valor at the Crusade Against Crimes 43rd Annual Medal of Valor ceremony in the St Louis area. With all of the news we hear lately, particularly “another catastrophe has been averted due to”, there must be other officers around the State that are deserving of our Law Officer of the Year Award as well. We are small in numbers but powerful in actions.

The purpose of Law Officer of the Year award is to recognize and pay tribute to a Law Enforcement Officer who has done an outstanding job of performing his or her duties at the level of his employment, as well as their off-duty contributions to the community, both past and present.

Candidates for this award may be obtained by seeking recommendations from the agency chief executive (Superintendent, Sheriff, Chief, etc.) or directly by a Voiture Locale. Some of the more specific guidelines are: a previous Law Officer of the Year may not be submitted a second time, the candidate must be living at the time of application, the candidate must reside in and perform their duties within the State, and the candidate need not be a veteran. HB 57 --- Sponsor: Fitzpatrick, Scott (158)
Co-sponsors: MILLER AND CURTMAN

Prohibits an agency, political subdivision, employee, or member of the military of Missouri from assisting an agency of the armed forces of the U.S. in the unlawful detention of a citizen

HB 73 --- Sponsor: [Barnes, Jay \(60\)](#) Co-sponsors: DAVIS AND BURLISON

Empowering circuit courts to establish "veterans treatment courts" to preside over judicial supervision, drug testing, and substance abuse and mental health treatment for active and retired military personnel

HB 88 --- Sponsor: [Burlison, Eric \(133\)](#)

Allows a circuit court to establish a veterans treatment court to dispose of criminal cases which stem from substance abuse or mental illness of military veterans or current military personnel

Establishes the Uniform Military Voters Act

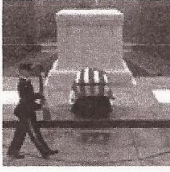

MEMORIAL DAY IN ARLINGTON NATIONAL CEMETERY



The Forty and Eight Memorial Day Ceremony is an annual event hosted by the 40 & 8 Memorial Day Committee. Planning for the weekend starts in October for the next year's Memorial Day Ceremony in Arlington National Cemetery. The Sunday evening banquet includes the Calvin Kain Memorial Service. Monday is a solemn occasion when we attend and participate in the National Memorial Day Ceremony at the Amphitheater in Arlington National Cemetery. At this event, Voiture Nationale and Cabane Nationale Drapeaux are marched into the Amphitheater. After Memorial Day addresses are given by the President of the United States and the Chairman of the Joint Chiefs of Staff, the Chef de Chemin de Fer and La Presidente

Nationale are invited to present a wreath at the tomb of the Unknowns. This is the only time that the 40 & 8 and La Femme leaders are recognized publicly by the US Government.

In 2001 we started a tradition of giving a US Flag to everyone entering the amphitheater. Because this requires about 10,000 flags, the committee requests donations. If you can help, please send your contribution to the Committee (as shown on the registration form). All donors will be listed in the Program Book. This is truly a weekend to remember and it is OPEN to everyone who would like to attend. Because of limited space, we recommend you register early.

The weekend is largely financed by the Memorial Day Program Book, so even if you are unable to attend, please consider purchasing an ad or being a booster.

I know that everyone enjoyed the Holiday Season, family, friends, food and gifts and just that general feeling of celebration and togetherness. I know that I personally had a wonderful Holiday. However we must realize that some of our friends, comrades, fellow Voyageurs, Dames and others were not as fortunate. I am of course speaking of the victims of Hurricane Sandy in the Mid-Atlantic and Northeast United States. These people are still in the midst of recovery from the second most deadly natural disaster since Hurricane Katrina and as most of you have seen in the news, the federal government is once again very slow with financial aid. This is really a terrible shame and our citizens deserve much better. Now enter the Forty and Eight and the La Femmes to show the heart and character to aid our fellow man in time of need.

I have not sent out any recent news on the support that the Voyageurs and Dames have offered these individuals because we were all involved with the holidays in our own little worlds and concentrating on our immediate families and friends, but now is the time to address this need once again. First I want to extend my sincere thanks to all of you that have made donations to the Sandy Donation Appeal fund, your generosity is amazing. This country is comprised of the finest people on the face of the earth and the Voyageurs and Dames reflect the best of the best. Once again, thank you to all of you that have already supported this project, you truly represent the character and passion of our organization. Now I want to impress upon everyone that there is still a very large need for help.

You may have noticed that the news coverage of Hurricane Sandy is no where near the extent it was when Katrina struck, even though this area affected is much more populated. I believe this may be due to other events that dominated the news coverage. The Presidential election, fiscal cliff and of course the horrible shooting in Newtown, CT. But none the less the need to aid these victims of Sandy is still there. Believe it or not, as of Christmas there were still people without power and some that were still homeless and living in makeshift shelters. One of the things that make this country so much greater than others is that Americans always rally to the need of one another, and I know this case will be no different. So once again I am putting out the call for the Sandy Donation Appeal.

This project is sponsored by the Child Welfare Program and administered by Voiture Nationale in a separate fund that will respond to claims by the Ardery Trust Fund Committee. That Committee is comprised of Past Chefs de Chemin de Fer Bob Kaseman, John Digilio, Jr. and Bob Molina.

I, as the Directeur of the Child Welfare Program, and with your help, am just trying to help raise the funds to make it possible for the Ardery Trust Committee to be able to answer all of the claims that we receive. Make no mistake about it, these funds are for the victims of Hurricane Sandy and are not a substitute for support of the Child Welfare Program, this is a special one time Appeal, but however it may be used as credit on your Child Welfare year end reporting as credit for your Grande or Locale.

We will extend this donation project for one fiscal year from the date of Hurricane Sandy's strike to the affected area, so that will be until early November 2013. So if you, your Locale or Grand has not found room in your budget at this point, I beg you to do so. I realize that every Voyageur, Dame, Locale and Grande has different financial needs and abilities, but it is my hope that everyone can find something to support this Appeal. Remember, no donation is too small because it is what you can do and that is all that counts. Other organizations are also working to raise funds to assist these families and one that is worth mentioning is the American Legion. They have begun a Sandy fund raising campaign under their National Emergency Fund. So as you can see when disaster strikes the American people, the first responders are veterans and the woman's organizations that support them.
