Due to the current state and extended impact of the COVID 19 Pandemic the Grand Chef de Gare Janice Hartley asked Grand Executive Committee and Grand Cheminot to vote on if the Grande should cancel the Grande Promenade on June 19-21, 2020 at the Oasis Hotel, Springfield Missouri. That vote was to cancel the Grande Promenade.

The Grand Executive Committee and Grand Cheminot were also asked if the current Grande Officers be retained for another year or have a Grande Promenade in August 2020.

The vote was to cancel the Grande Promenade for June 19-21, 2020 at the Oasis Hotel, Springfield Missouri and to have a Grande Promenade in August.

The Grande Promenade is set for Saturday August 29, 2020 at noon at American Legion Post 331, 484 St. Robert Outer Road, St. Robert, Mo 65584. There will not be a Grande Cheminot just a Grande Promenade. We will conduct the necessary business such as election of Officers and Delegates, Directeur's reports and the like. It is estimated it will last 2 to 3 hours. There will not be a banquet or any committee meetings.

Depending on the health situation at the time there will be health safety precautions in place at the August 29th Grande Promenade.

The letter in the newsletter from Terry Sims Correspondant Nationale was addressed to the Grand Correspondants and refers to what the Grands can do as far as the Grands election. I thinks the Locales can us the same theory concerning their elections. The Locales need to first look at their constitution first to see what it says about elections. Most of the Locales constitutions will probably state Locale Officers will keep their job until their successors are elected and installed in office.

Election Suggestions

We are in a time that we have never experienced before and therefore have never made any preparation or operating procedures for National Emergencies as the COVID-19 pandemic. We must make some temporary adjustments to accommodate the voting process for election of officers until we can resume normal operating procedures. Once back to normal, we should amend Constitutions and Bylaws to accommodate this rare occurrence or situation to make an operational plan.

The National Constitution has no provision for any type voting or decision making regarding elections and Constitutional issues other than resolutions, amendments and a floor vote. The floor vote constitutionally is done only by delegates and they must be present on the floor to vote, no proxy or call in votes are permitted. This presents a problem when we are restricted by the social distance guidelines that have been issued. Now we find ourselves in a proverbially "Catch 22" situation, not being able to vote by teleconferences (e-mail) due to the Constitution and not being able to amend the Constitution without a proper Promenade with delegates attending and being there to vote in person.

What I believe we should do during this COVID-19 crisis, until we are able to meet and conduct business as usual, leaves us with several options: Each Grand could have an Executive Order issued by the Grand Chef de Gare, with the consent of Cheminot or whatever governing body they have established, stating that teleconference (e-mail) or voice mail and if necessary USPS voting would be allowed by verified delegates or terms of current officers would be extended until a proper Promenade is scheduled. Once we have recovered and can meet safely, the officers that were elected could finish their terms or a provision could be made in the Executive Order to hold an election at the proper Promenade by the Constitutional Order and have the delegate vote in person from the floor. This would have to be stated up front if that were the intention.

I hope this assists you in your decision making. I know that you are aware that our Constitution states that whenever any issue is not defined in our Constitution that we refer to Roberts Rules of Order, however, I don't believe that Roberts Rules of Order made any provisions for what we, as a country, are dealing with in this unprecedented time, so I believe that we need to refer to the oldest reference source known to mankind, the rule of Common Sense.

This is not an official ruling or statement from Voiture Nationale, it is merely a suggestion from the Chefs de Chemin de Fer passes and Cheminot Nationaux 2020 and we feel very strongly that anyone would find it difficult to make a point that you were "unconstitutional" in your Promenade decisions. To insure continuity, we suggest you inform the Locales of the decisions you intend to put forth during these temporary, unchartered times.

Many Grand and Voitures Locale have Constitution and By-Laws which do not define the times that we find ourselves.
