In signing this application, we hereby waive and release all other contestants, the host, sponsors, club officers and tournament officials from all claims for injury and/or damage incurred in connection with this tournament. We further agree and understand that the tournament committee reserves the right to refund entry fees, if they shall choose for any reason, not to accept this application. VERIFICATION OF LIABILITY INSURANCE: I further state that I maintain at least \$100,000 liability insurance on the boat that I will use in this tournament.

Official Rules: The Missouri Veterans Annual Open Bass Tournament May 5, 2007

- 1. Rules: The following rules for this tournament will be used. These rules will be interpreted solely by the Tournament Officials, and all decisions are final. Violations of Department of Conservation or State Water Patrol regulations shall be reason for disqualification. Failure to read these rules is no excuse for violating them. Knowledge of rules is your responsibility. Violation of the rules is reason for disqualification.
- **2. Eligibility:** All individuals, 18 years of age or older, with paid entry fee. Individuals under 18 years of age must be accompanied by parent of guardian. Two fisherman per boat are required.
- 3. Entry Fee: \$110.00 entry fee per boat, which includes the Big Bass Pool. Entries will be accepted by mail postmarked no later than April 20, 2007. Any entries received with a postmark later than April 20, 2007, will be required to pay a late entry fee of \$25.00. Late entries will also be accepted at the Lake of the Ozarks, Public Beach 2 (PB2) dock between 5:00 AM and 6:30 AM on Saturday May 5, 2007. The late entry fee at PB2 dock is a \$135.00 Cash Only fee, which includes Big Bass Pool.
- **4. Prizes:** Tournament prize winners will receive winnings by check at the conclusion of the final weigh-in at Tournament Headquarters, PB2. Prize monies for ties will be combined, and divided evenly for the Big Fish Contest. A boat is limited to only one Big Bass prize. We are required by law to issue a Form 1099 to any person winnin more that \$600.
- 5. Headquarters, Date, Time: Lake of the Ozarks, PB2, May 5, 2007, Fishing take-off time is 7:00 AM. Sunrise is 6:10 AM. Weigh-in time is 3:00 PM.
- **6. Live-Well Checks:** Live-well checks will begin at 5:00 AM at PB2. All entrants must participate in live-well checks.
- 7. Departure: Will be in number sequence determined by date entry fees are received.
- 8. Tackle & Equipment: Only artificial baits or lures may be used. Pork style baits are allowed. No live bait allowed. No trolling allowed. All bass must be caught alive on rod and reel during tournament hours from a boat in a sporting manner.
- 9. Boats & Equipment: any boat 14 feet or longer will be accepted if powered by an engine of 10 horsepower or more. Boats must be equipped with a functional aerated live-well. Boats may not be trailered during tournament hours. Boats may not have motors which exceed the horsepower rating or B.I.A. rating placed on the boat. All Missouri Water Patrol Laws and regulations shall apply.
- 10. Safety & Sportsmanship: Safe boating and fishing practices must be observed at all times. Life jackets must be worn and ignition kill switches must be on during departure and at anytime the big motor is running. No boater will be allowed to fish alone. Unsportsmanlike conduct will not be tolerated and will be grounds for disqualification. All Missouri Department of Conservation laws and regulations shall apply. No alcoholic beverages, stimulants or depressants are allowed to be used during tournament hours. REMEMBER This is a tournament for charity.
- 11. Permitted Fishing Locations: Anywhere on the lake, except within 50 yards of a public gas dock, or another contestant's boat, tied or at anchor with trolling motor up; at PB2 or any area designated by the tournament officials prior to take-off. No contestant may leave their boat to land fish.
- 12. Scoring: Largemouth bass, Kentucky Bass, Smallmouth bass and Mean Mouth Bass will be counted. Total stringer weight per team will determine place. Any bass under 15 inches presented for weight-in will cause two(2) pounds to be subtracted from total stringer weight, plus the loss of the short fish. The Official Ruler is the "Gator Grip Golden Rule." Any bass determined dead when presented for weigh-in (as determined by Tournament Officials) shall result in one half (1/2) pound penalty per dead fish, to be subtracted from the total stringer weight. Five (5) fish per boat may be weighed in. Any frozen, iced or mangled fish presented for weigh-in will result in immediate disqualification.
- 13. Protests: Signed protests must be submitted in writing to the Tournament Director within 15 minutes of the conclusion of final weigh-in.
- 14. Truth Verification: By the signature on this entry form and/or participation in this tournament, each contestant agrees to submit to a polygraph test. Anyone failing to pass will be disqualified and anyone refusing to take the test will be disqualified.
- 15. Check-in & Late Penalty: Each entry must check-in, anyone weighing-in fish that did not check-in will be disqualified. Late penalty is one (1) pound per minute up to 10 minutes. After 10 minutes, team will be disqualified. NO EXCUSES. All participants are requested to check-in, regardless if weighing fish or not.
- 16. Tournament Cancellation: If tournament is cancelled due reasons of safety, etc., the entry fee will be refunded. No refunds will be made for any other reason unless authorized by Tournament Sponsor, the 40 & 8 Officials.
- 17. Waiver: Through our entry fee, you waive and release all other contestants, the host, the sponsor, 48 & 8 Society, and tournament officials from all claim and/or damage incurred in connection with this tournament. By signing the entry form, you acknowledge you have \$100,000 boat liability insurance.
- 18. This is a Catch and Release Tournament.


